Background:

Bylaw C12-16 is an amendment to Road Closure Bylaw C3-15.

In the fall of 2008, the City completed a capital project to extend 86 Avenue from 101 Street to 109 Street. The extension of 86 Avenue resulted in reconfiguring the intersection at Cemetery Road and 109 Street. This created surplus road right-of-way lands.

Subsequently, Bylaw C5-09 was approved on June 23, 2009 to close the surplus road right-of-way lands. However, this Bylaw was rejected by Alberta Land Titles because of an error in the legal description.

Bylaw C3-15 was approved on January 13, 2015 to amend the legal description in Bylaw C5-09. This Bylaw was also rejected by Alberta Land Titles because the legal description provided by the surveyor did not meet their requirements.

Bylaw C12-16 will amend the legal description in Bylaw C3-15. The surveyor has provided a revised legal description that has been reviewed and approved by Alberta Land Titles.

The lands created by this road closure will be consolidated with Lot 1, Block 2, Plan 042 4820. This lot is owned by the City and is zoned UR- Urban Reserve District.

Recommendation:

That Council give three readings to Bylaw C12-16, amending Road Closure Bylaw C3-15 (Cemetery Road and 109 Street).





Bylaw C13-16 to Close a Portion of the Old Pointe aux Pins Road Allowance in Westpark

Motion:

That Council give first reading to Bylaw C13-16 to close a portion of Pointe aux Pins Road in Westpark.

Purpose:

To close the old Pointe aux Pins Road allowance, which will be included as part of the City's trail network, and to request consideration of first reading of Road Closure Bylaw C13-16.

Background:

The City, Landrex Inc., and Westpark Land Company Ltd. are in the process of converting a 750 meter section of Pointe aux Pins Road to municipal reserve and a multi-use trail. This section of Pointe aux Pins Road is north of Woodhill Lane and will be bordered by residential properties. The future municipal reserve will be 20 meters wide, and will accommodate a 3 meter wide asphalt multi-use trail. This application will continue the process of converting land from Pointe aux Pins Road to accommodate a trail through Westpark.

A road closure is required to close the Pointe aux Pins Road right-of-way. The lands will be given a legal description when the road closure plan is registered with Alberta Land Titles. The lands from the Pointe aux Pins Road Closure will be dedicated as municipal reserve to the City with a subdivision plan. The City is working with the Developers to complete a Development Agreement for park and trail construction.

Plans/Standards/Legislation

The lands are designated as "General Urban Area (GUA)" in the City's *Municipal Development Plan*. The lands are designated as "Park" in the *Westpark Area Structure Plan*. Further details and analysis regarding applicable policies will be outlined in the subsequent report to Council.

As per the *Municipal Government Act*, if Council gives Bylaw C13-16 first reading, affected landowners will be notified by mail. A Public Hearing advertisement will be published in the local paper for 2 consecutive weeks. The target date for the Public Hearing is September 13, 2016, and will be held in Council Chambers at 6:00 p.m.


