### Preparing for the Future

### **Grants to Organizations Overview**

The City of Fort Saskatchewan supports various community non-profit groups, organizations, boards and committees. Financial support is categorized as Grants to Organizations in the annual budget. Grant-in-kind support to community organizations has also been provided as information; along with non-financial support which is provided through various agreements and contracts.

### Financial Support

The majority (71%) of the City's financial Grants to Organizations supports the Fort Saskatchewan Public Library's day-to-day operations. The remaining Grants to Organizations, in large part, support Special Transportation Services Society (STSS), Families First Society, the Boys and Girls Club and the Volunteer Programs Association.

The attached Grants to Organizations summary report provides details of \$1,649,173 in financial support proposed for the 2017 budget.

### Grant-in-Kind Support

For 2017, we have included organizations who do not receive financial funding from the City, but receive grant-in-kind support. These organizations include: Families First Society for the old RCMP building maintenance, Pioneer House Club 50 for the Pioneer House building maintenance, Scouts & Guides Hall for building maintenance and the Fort Saskatchewan Public Library for building maintenance and financial services.

The attached Grants to Organizations summary report provides details of \$123,775 in grants-in-kind support proposed for the 2017 budget.

### Non-Financial Support

The attached Community Groups/Organization Leases report provides information on the City's current lease agreements with community groups and organizations. Non-financial support for these community groups and organizations varies from minimal rental rates to market value rates for the use of City owned property and/or buildings.





- There has been no accommodation for inflation over the last 14 years.


- Municipal Reserve was built up to \$798,000 in the period from 2002 to 2010.
- Municipal Reserve has been drawn down since 2011 and will be depleted by mid-2018.
- Upon receipt of Provincial grant in 2009 the municipalities discontinued reserve contributions
  - Provincial grant allows for an average of 60% funding of operation and communication expenses
  - The remaining "matching" funding of operations has come from a combination of annual municipal operating contributions + a draw on the municipal reserve
- Replace the annual draw on operating reserve with a corresponding addition to annual operating contribution

### **Background:**

The RVA Vision and Mission as referenced in the 2016-2020 Business Plan are:

**Vision**: To create a continuous world class metropolitan river valley park system from Devon through Parkland County, Leduc County, Edmonton, Strathcona County and Sturgeon County to Fort Saskatchewan.

**Mission**: To preserve, protect and enhance the river valley becoming recognized as one of the largest and best river valley park systems in the world for the year-round accessibility and enjoyment of its citizens and visitors.

- The RVA has been successful in garnering \$80,000,000 from incremental provincial and federal governments to support the municipal investments in the river valley park system.
- The RVA targets to raise more than \$150,000,000 to support the NEXT PHASE Capital Program of 2017-2022.
- The RVA aspires to realize its Vision and Mission through the introduction of Marketing, Branding, Events and Communications to achieve the Outcomes identified in the Plan of action:
  - 1. Pride To create a source of unparalleled pride in the Capital region and throughout Alberta
  - 2. Legacy To preserve an outstanding legacy for all Albertans
  - o 3. Quality of Life To improve the quality of life for people in the Capital Region
  - 4. Attraction To attract businesses and residents to the Capital Region
  - 5. Tourism To enhance tourism in the Capital Region and the province
- The RVA sources operating funds from (Attachment 2 Municipal Contributions):

Municipal Annual Operating contributions (\$110,000 in 2015)
 Municipal Reserve Funds (\$126,000 in 2015)
 Provincial Grant Operating (\$393,000 in 2015)
 Investment interest/ private contributions (\$9,000 in 2015)

- Municipal annual operating contributions have remained static since 2002(?) at \$110,000 (\$50,000 from Edmonton plus in-kind services, \$10,000 from the other six shareholders,). There has been no accommodation for inflation over the last 14 years.
- Since the receipt of the Provincial grant in 2009, operating funds have been sourced in the following proportion:

- Provincial ~ 60%
- Municipal ~ 35%
- Investment interest/ private contributions ~ 5%
- At the Board at the 2015 Planning Retreat, the Board recognized the value of the continued operation of the RVA
  upon the expiration of the current provincial and federal grant funding to garner more funds and continue as a
  forum for inter-municipal collaboration and to steward the river valley park initiatives.
- The RVA Municipal Reserve was built up to \$798,000 from contributions incremental to annual operating contributions in the years up to the receipt of the provincial grant in 2009. Reserve contributions were discontinued after the receipt of the provincial funding. At the end of 2015 the unrestricted municipal reserve was \$496,000.
- The execution of 2016-2020 Business Plan would have the unrestricted municipal reserve depleted by mid-2018.
- The Budget forecast for 2016-2020 proposes the annual unrestricted reserve draw be replaced with an increase in annual operating contributions in 2017 and forward to sustain the unrestricted municipal reserve at ~\$300,000. This reserve would serve as an operating contingency.
- The provincial government capital and operating grant will expire as of March 31, 2018. Renewed funding in the form of an incremental grant of \$50,000,000, inclusive of the operating contribution formula, will be requested. Should this request not be successful the Board has accepted an approach of requesting the unexpended interest from the 2009 grant be designated for future operating support purposes.
- The RVA Business Plan 2016-2020 forecasts a combined municipal operating and reserve contribution of \$250,000 annually. This will be reduced in 2017 budget to reflect the proposed \$240,000 municipal contributions.







#### Electrical upgrade - \$2,000

At present the power is supplied through the village's own electrical circuitry, which has no capacity to take any additional load. This upgrade would tap into new washrooms, then be disconnected from village increasing village capacity.

#### **Dust collection - \$2,000**

We are currently using a loaned system which partially removes the dust but would like a permanent dust collection system

#### Compressed air system - \$800

With the varied work activities and tools a permanent compressed air system would increase versatility, we have the compressor just need piping.

#### Sandblast Unit - \$300

Working on many artifacts entails a large amount of cleaning, rust removal etc. We have a donated unit just need associated tooling and piping.

#### Tools - \$1,150

Over the past number of years we have been adding to and upgrading our array of tools, but with the NWMP Viewing Platform scheduled for next year places the need to upgrade and replace the following tools: - Compound Mitre Saw, Air Nailer and Battery Operated Power Drill

This request for \$6,650.00 of additional funding is to cover associated costs of material and tools only, all work/permits will be handled by qualified people of the workshop group.






#### Council Presentation 2016

Good evening. I'm Sharron Roberts, chairman of Special Transportation Services Society, or STSS.

Mayor Katchur and members of city council, thank you for allowing me to speak to you this evening. Some of my board members are here with me this evening.

As you know, we have been function since 1980, providing subsidized transportation for seniors, disabled, chronically ill, and some short term disabilities. Our taxi service with Driving Miss Daisy is used by the majority of our clients, but we also have the wheelchair accessible vans for those unable to access the taxi service.

Our services remain in demand. DMD averages 346 in town and 80 out of town trips every month. The handivan averages 87 in town and 21 out of town trips every month

As our handivan is 11 years old, we purchased another MV1. As the MV1 is more economical to run, and the demand for the larger van is minimal, we felt this was a better use of our funds. As the new MV1 is now here, we will be selling the handivan. As we had already raised most of the funds for the new van, we did not have a fundraising drive this year. We had our second casino in August, and are now waiting for the proceeds to pay the remainder of the costs. The board would like to thank Arjun for his help at the casino.

We have seen an increase in the need of some clients to require a full subsidy when using our services.

We continue to need more board members, so some members are doing more than 1 duty.

We did receive an honor this year. Gail Steeves nominated our board foe the Senior Services award. We were 1 of 8 groups or individuals to receive a special award at Government House in September. Thank you Gail.

Although we are not requesting a budget increase, we wanted to share all our good news with you.



The Boys and Girls Club facilitated two programs with the project.

- The Fourth R program:
  - educates youth ages 12-17 on topics such as healthy relationships, substance use, and mental health
  - We facilitated the program in Our Lady of Angels School to 91 youth in grade 7
  - In September, the program began in both OLA and JP II and is serving 138 students in the community.
- In School Mentoring:
  - match adults with a child or youth in the school one hour per week to foster a positive relationship
  - By September, we have engaged 5 schools
  - We have mentors matched with 4 students
  - We have currently completed intake on 6 mentors, and have completed intake on an additional 7 youth.

## CAREER CAFÉ



In an effort to greater develop our Youth Employment Strategy, the Boys and Girls Club partnered with Careers Under Construction and Heartland Ford to create a new youth based employment program. In May 2016 the Career Café opened in Heartland Ford.

#### The program is:

- 10 weeks in length
- Places youth in the Heartland Ford Career Café to gain hands on experiences
- Teaches customer service, safe food handling, and working in a fast paced environment
- For youth ages 15-24





### Objectives of the Fort Saskatchewan Prairie Stewardship Program


- -improve and maintain the natural integrity of the Prairie by appropriate site management  $\,$
- -recruit volunteers so that sustainable stewardship can be maintained
- -outreach and provide interpretation to the community (achieved so far with brochures and a bulletin board)
- consult with City Council, Administration and the community on issues important to maintaining the health of the Prairie.



#### **Management Activities in 2016**

- Weeded and prepared beds for transplanting on the northernmost slope and "hollow" and in the "second hollow" where there was extensive infestation of weeds.
- Transplanted native plants from a sandy soil pasture near Gibbons that is to be stripped for road widening.
- Transplanted with nursery-raised transplants.
- Mulched and watered the beds.
- Weeded the area generally. Weeding was done by hand-pulling, digging and some use of herbicide.
- Maintained the trail (now largely a single-file trail).
- Collected seed for raising of transplants.
- Liaised with the City for water provision and garbage removal.

Note: Both volunteer and paid labour was used in these management activities in the ratio of 64 paid hours to 95 volunteer hours.



#### **Activities Planned for 2017**

- An early-season start on weeding, using paid labour, is planned, as the most cost-effective method of keeping weeds under control. If funds permit, regular weeding will continue throughout the season.
- More transplanting of plants grown off-site, but raised from seed collected from the Prairie.
- Record location of transplant beds and contents on a map provided by the City and monitor to assess survival and growth.
- Investigate the possibility of obtaining a community grant to employ student labour for part of the summer.
- Approach McClay Ecoscience re using the Prairie as an experimental station for biocontrol of the noxious weed yellow toadflax.
- •Develop a colour brochure (Edmonton Native Plant Group) (similar to the one that already exists for the plants of Fort Saskatchewan Prairie) on the weeds (non-native plants) of the Prairie. This will help field workers discriminate between weeds and native plants.
- Organize at least one outreach event, such as a field trip, locally advertised.



Dear Mayor Katchur and Councillors:

Re: Fort Saskatchewan Prairie Stewardship Program

I regret that I will be unable to be present at the October 27 Council meeting on the budget for 2017 as I will be out of the country on vacation on that date.

I can, however, report that our Fort Saskatchewan Prairie Stewardship group continued our caretaking activities in the Prairie this year and plan to do more of the same next year.

The expenditure of \$1,587.50 on paid labour and the input of 90 volunteer hours (albeit from a limited number of volunteers) this year have enabled us to make good progress with the enhancement of the native plant communities in the Prairie. Activities have included weed removal, preparation and transplanting with native plants of restoration plots, seed collection on-site, and trail maintenance.

Native plants were obtained from two main sources: salvage from a similar sandy-soil native prairie north of Gibbons being developed for road widening; and plants grown from Prairie-collected seed by the Edmonton Native Plant Group.

We were assisted by the Departments of Public Works and Parks in the provision of water for the transplants and the removal of garbage (mainly weeds).

Our goal for the future continues to be maintenance of the Prairie's native plant communities and their gradual extension through removal of non-native smooth brome patches followed by replanting. We will be recording location and species content of restoration plots on large-scale aerial maps provided by the City in order to monitor survival and growth of the transplant species.

Another objective is to develop a program to recruit local volunteers, both to promote local appreciation of the Prairie and eventually to reduce expenses (approximately \$1,100.00 was claimed for travelling expenses this year and not all trips were claimed for). We would welcome any assistance the City can provide with an outreach project. We do plan to hold at least one locally advertised guided field trip in 2017.

Since it is unlikely that we will be able to recruit enough volunteers in the immediate future through outreach, we expect to continue to rely on temporary paid labour in 2017, so labour costs will again be a priority for spending. We will continue to work with the \$3,000 in grant funding the City generously offers. However, an increase of \$1,500 would allow us to employ labour for longer during the season, enabling us to get control of weeds earlier and thus save maintenance costs in the long term. In addition, since free salvage of native plants will not be available in 2017, we anticipate that costs for seed-raised plants will be higher.

We hope to be able to engage McClay Ecoscience in a trial of a biocontrol agent on toadflax next year.

A further goal is to engage the Edmonton Native Plant Group to produce a brochure on the Prairie's weeds, the better to assist our field workers in weed identification and discrimination from native species.

The Fort Saskatchewan Prairie is a valuable amenity for the City and we are pleased to see more people using its trails responsibly. Although our ultimate goal is to reach a stage where the natural communities are more self-sustaining and require less maintenance, ongoing stewardship is currently necessary if we are to maintain the progress we have made. Hence I respectfully request Council approve funding of \$4,500 for 2017.
