



## CITY OF FORT SASKATCHEWAN

### A BYLAW OF THE CITY OF FORT SASKATCHEWAN IN THE PROVINCE OF ALBERTA TO CLOSE A PORTION OF GOVERNMENT ROAD ALLOWANCE WEST OF NW, SW 25-54-23 W4M.

#### BYLAW C2-20

**WHEREAS** the *Municipal Government Act*, R.S.A.,2000, c.M-26 as amended or repealed and replaced from time to time, provides that a municipality has the power to amend the Land Use Bylaw;

**NOW THEREFORE**, the Council of the City of Fort Saskatchewan, in the Province of Alberta, duly assembled, enacts as follows:

1. That the City of Fort Saskatchewan hereby close the following described government road allowance lying within the limits of the subject area:

MERIDIAN 4 RANGE 23 TOWNSHIP 54

ALL THAT PORTION OF THE GOVERNMENT ROAD ALLOWANCE  
ADJOINING THE EAST BOUNDARY OF THE SOUTH EAST QUARTER OF  
SECTION 23, WHICH LIES BETWEEN TWO LINES DRAWN PARALLEL WITH  
AND 422 M AND 437 M PERPENDICULARLY DISTANT NORTHERLY FROM  
THE SOUTH BOUNDARY THEREOF  
EXCEPTING THEREOUT ALL MINES AND MINERALS

MERIDIAN 4 RANGE 23 TOWNSHIP 54

FIRSTLY:

ALL THAT PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE  
ADJOINING THE EAST BOUNDARY OF THE EAST HALF OF SECTION 23  
WHICH LIES NORTH OF A LINE DRAWN PARALLEL WITH AND 437 METRES  
PERPENDICULARLY DISTANT NORTHERLY FROM THE SOUTH BOUNDARY  
THEREOF EXCEPTING THEREOUT ALL MINES AND MINERALS.

SECONDLY:

ALL THAT PORTION OF THE GOVERNMENT ROAD ALLOWANCE  
ADJOINING THE EAST BOUNDARY OF THE SOUTH EAST QUARTER OF  
SECTION 23, WHICH LIES BETWEEN TWO LINES DRAWN PARALLEL WITH  
AND 40M AND 422 M PERPENDICULARLY DISTANT NORTHERLY FROM  
THE SOUTH BOUNDARY THEREOF. EXCEPTING THEREOUT ALL MINES  
AND MINERALS.

2. If any portion of this Bylaw is declared invalid by a court of competent jurisdiction, the invalid portion must be severed and the remainder of the Bylaw is deemed valid.
3. This Bylaw becomes effective upon third and final reading.
