Reference - Condominium Waste Removal Charges

We represent various Condominium Corporations, as listed below here, with residential buildings in the City of Fort Saskatchewan.

We make this presentation to you requesting refunds for the inequity in waste removal charged to each of us for the period July 1, 2012 to December 31, 2014.

For the aforementioned period we were charged at rates that apply to properties receiving curb side collection. Thus, the charges were based on the number of suites in each of our buildings. We maintain that this was the root cause of the inequity and should have been charged as properties receiving front load collection. We maintain that we should have been classified as multi-unit properties. We maintain that the City's costs for Waste Removal for curb side collection are significantly higher than they are for properties receiving front load collection.

We have in the recent past had meetings with Councillor, Stew Hennig and representatives of the City of Fort Saskatchewan. As a result of these meetings, the City's Administration as of January 1, 2015 have acknowledged the inequity in our waste removal charges. Consequently, effective January 1, 2015 and subsequently, we are being charged as properties with front load collection. The charge per month has been reduced to \$14.00 per unit per month compared to the \$22.79 per month per unit that we were charged for December, 2014.

I am enclosing herewith a couple of schedules which indicate the waste removal charges for the period January 1, 2012 to December 31, 2014 for your information.

We sincerely request your consideration and your approval for the City's Administration to reimburse each of us for the difference in charges for curb side collection compared to front load collection for the period July 1, 2012 to December 31, 2014.
